**Re: AFTRS NIDA Collaboration – *One More Day***

We, the undersigned, are writing to you to express our concerns over the National Institute of Dramatic Arts' (NIDA's) collaboration with the Australian Film Television and Radio School (AFTRS).

It is our understanding that the full time final year students will be performing in a project titled *One More Day*. We support this project moving forward as a benefit to all involved and appreciate the need to view this production differently with respect to the terms and conditions for working on this production. For example, we understand that, as agreed by the students, there will be no up-front payment.

Our concern with this project however is centred upon the potential sale of the end product to a commercial Australian television network.

The repercussions of a potential sale to a network (and its substantial precedential value) are not insignificant. A sale to an Australian commercial network of a production where no cast or crew members have been paid will directly take paid employment away from both NIDA graduate and non-graduate performers and other crew who would ordinarily work on a production that would be used by the network to acquit their obligations under the Australian Content Standard.

The Australian commercial networks always have a keen interest in reducing their spend on Australian content and this is particularly the case with the current financial crisis. The purchase of this film would more than likely be at a rate cheaper than one produced under typical commercial terms. The purchase of a feature film will also provide them with maximum points under the drama sub-quota of the Australian Content Standard. This makes the purchase of this production at a level cheaper than they would normally have to pay for another feature film a much more attractive proposition.

With this in mind, we seek an undertaking from you that such a sale will not take place.
